Entry Requirements



Please make sure that you fulfill the entry requirements for each port of your cruise. If there is any doubt, please contact the consulate of said country to check the current entry requirements.

Your Passport has to be valid at least 6 months after the end of your voyage for all countries, regardless of destination. Please also make sure that you have enough free pages in your passport available.

The following entry requirements are only relevant to **Norwegian citizens**:

Please make sure you have all current information about vaccinations as well. E.g. a Yellow Fever vaccination is required at some ports in Africa and South America.
